**Presentation : Computer Integration 7 & 8 – A. Cirella**

Kevin Eppley presented an overview of Technology Education for grades 7 & 8.

- What is Technology
- Patterns, Forces and Measurement
- Transformation of Energy

Presented were the Units of Technology Education Grade 8:

- What is Engineering
- Aerodynamics and Transportation
- Electrical Engineering

**Assistant Superintendent Update – A. Uberti**

Professional development will be offered to all district paras on Thursday, March 17, 2022. A. Uberti has collaborated with the director and supervisors of special education to plan a variety of offerings for the para staff. Sessions are presented by certified staff with knowledge and experience in specific areas. Session topics include strategies for promoting student independence, de-escalation techniques, supporting students on the autism spectrum, supporting students with executive functioning and attention deficits, implementing behavior plans and strategies for supporting English language learners.

The winter administration of i-Ready has been completed and reports were mailed home to parents. I-Ready is new to the district this year. It was first given in the fall and this second session provides us with growth data for the first time. A. Uberti and F. Purcaro have been training the leadership teams of each school, K through 8, in analyzing the data and creating action plans. The expectation is that those teams bring that same training back to their staff.

The results of the i-Ready seem to confirm that there has been some learning loss due to the disruptions of the past two years. Due to the number of students who need additional support, it is imperative that teachers are equipped with the tools to provide instruction in the specific areas that students need. i-Ready provides many such tools for teachers to use in order to provide tailored instruction for classes, groups and individuals. Since i-Ready was launched as a pilot this year, teachers were not mandated to use the instructional tools. However, now that they have had time to better understand the results of the assessment, we are focusing our efforts on training and supporting the teachers' use of the instructional tools it offers. On a positive note, i-Ready also indicates that there has been tremendous growth since the beginning of the year so we are confident that, in time, we will be able to return students to their pre-pandemic learning levels.
